Secy./2026/AS-IV/ 9270-9310 Dated 16.04.2026 के संदर्भ में, महाविद्यालय के सभी यूजी/पीजी विद्यार्थियों को सूचित किया जाता है कि मुख्य/री-अपीयर परीक्षा हेतु Internship Report जमा करवाने की अंतिम तिथि 30 जून 2026 निर्धारित की गई है। रिपोर्ट जमा करवाते समय निर्धारित सामान्य शुल्क ₹1500/- जमा करवाना अनिवार्य है। 30 जून 2026 के बाद रिपोर्ट जमा करवाने पर निम्नानुसार विलंब शुल्क देय होगा:

एक माह तक	₹200 + ₹1500 सामान्य शुल्क
एक माह से अधिक एवं दो माह तक	₹1000 + ₹1500 सामान्य शुल्क
दो माह से अधिक एवं तीन माह तक	₹1500 + ₹1500 सामान्य शुल्क
तीन माह से अधिक एवं बारह माह तक	₹4000 + ₹1500 सामान्य शुल्क
बारह माह से अधिक एवं कोर्स अवधि तक	₹5000 + ₹1500 सामान्य शुल्क

अतः सभी विद्यार्थी निर्धारित तिथि से पूर्व अपनी इंटरनशिप/प्रोजेक्ट रिपोर्ट महाविद्यालय कार्यालय में जमा करवाना सुनिश्चित करें ताकि विलंब शुल्क से बचा जा सके। विश्वविद्यालय नियमों के अनुसार निर्धारित अवधि में रिपोर्ट जमा न करवाने वाले विद्यार्थियों को अनुपस्थित माना जा सकता है।

In the reference to GJUS&T, Hisar letter No. Secy./2026/AS-IV/ 9270-9310 Dated 16.04.2026, all the students of UG/PG classes are hereby informed that the last date for submission of Internship Report for Main examination is **30 June 2026** along with the prescribed normal fee of ₹1500/-.

Students submitting the report after 30 June 2026 will have to deposit late fee as per the following schedule:

Delay Period	Late Fee
Up to one month	₹200 + ₹1500 normal fee
Beyond one month and up to two months	₹1000 + ₹1500 normal fee
Beyond two months and up to three months	₹1500 + ₹1500 normal fee
Beyond three months and up to twelve months	₹4000 + ₹1500 normal fee
Beyond twelve months up to course duration	₹5000 + ₹1500 normal fee

Students are advised to submit their Internship Reports in the college well before the last date to avoid late fee charges.

Further, students who fail to submit the report within the prescribed period may be considered absent in the concerned paper as per university rules.

I am directed to inform you that as per decision of the Executive Council meeting held on 12.12.2025 & 16.01.2026 issued by the Result Branch vide their notification Endst. No. R-II/RC-MISC/2026/1103-1232 dated 25.02.2026 the last date for submission of Dissertations/Major Project/Project Work/Internship /Training Report/Thesis etc. by the students of UG/PG courses will be 30th June of the year concerned with submission fee of Rs.1500/-. And, in case late submission i.e. after 30th June, the fee will be charged as per the following schedule :-

Duration	Powers Vested in time to time.	Late Fee as Prescribed from
Upto one month	Controller of Exams.	Rs.200/- + Rs.1500/- normal fee
Beyond one month and upto two months	-do-	Rs.1000/- + Rs.1500/- normal fee
Beyond two months and upto three months	Vice-Chancellor	Rs.1500/- + Rs.1500/- normal fee
Beyond three months and upto twelve months	Vice-Chancellor	Rs.4000/- + Rs.1500/- normal fee
Beyond twelve months Onwards upto the end of duration of course.	Vice-Chancellor	Rs.5000/- + Rs.1500/- normal fee

Late fee as prescribed in each case will be chargeable.

Provided that if a candidate fails to submit the dissertation etc. even during the extended period of three months i.e. 30th September, he/she will be considered to have absented in the dissertation etc. paper and his/her result will be declared accordingly."

You are, therefore, requested to forward the Dissertation/Major Project/Project Work/ Internship/Training Report/Thesis etc. in respect of UG/PG students of your Department as per above schedule for main/re-appear exam. May/June, 2026. Further, it is informed that in case of re-appear students no Dissertation/Major Project/Project Work/ Internship/Training Report/Thesis etc. will be accepted after 30th June, 2026.
